Whereas, James B. Doyle was born in Jeffersonville, Indiana, on August 21, 1928, and passed from this life in Indianapolis, Indiana, on November 5, 2006; and

Whereas, James B. Doyle moved to Indianapolis early in his life after short stays in several other Indiana communities, attended St. Joan of Arc Grade School, Cathedral High School, and Butler University, and was an outstanding basketball and baseball player in both high school and college; and

Whereas, James B. Doyle served as Head Basketball Coach and Head Baseball Coach at Cathedral High School following his graduation from Butler, turning down an opportunity to play major league baseball; and

Whereas, James B. Doyle joined his father in the furniture business at 30th and Illinois Streets, later moving to 86th and Westfield Boulevard in Nora. Following a devastating fire in 1962 he reinvented his business to become a successful, respected "shop at home" purveyor of carpets and floor coverings; and

Whereas, James B. Doyle quietly accepted, then rose above the family misfortunes that came his way in life with serene dignity and grace; and by being a living example of advice once read that the best thing a father can do for his children is to love their mother; and

Whereas, James B. Doyle was a loyal, active and dedicated member of the Junto of Indianapolis for 16 years serving as a member of the Board of Directors in 2004 and 2005; and was greatly loved, respected and admired by all members.






